

## MoneyGram Plus Rewards™ Kick-Off Promotion Official Rules

- 1. Eligibility: The Promotion is open to all active U.S. MoneyGram retail agents at the headquarter level ("Agents") who are eligible to promote the MoneyGram Plus Rewards loyalty program. Agents located in Puerto Rico and the U.S. Virgin Islands are not eligible to enter or win. MoneyGram Key Partners, including their associates, affiliates, owners, directors, and employees, are not eligible to enter or win. This Promotion is void outside the U.S., or where prohibited or restricted by law and is subject to all applicable federal, state, and local laws and regulations.
- 2. Sponsor: The MoneyGram Plus Rewards Kick-Off Promotion (the "Promotion") is sponsored by MoneyGram Payment Systems, Inc., and its subsidiaries (collectively, "Sponsor"). By participating in this Promotion, Agents accept and agree to be bound by these rules and the decisions of the Sponsor, which shall be final and binding on all matters. Sponsor reserves the right to verify to its satisfaction the eligibility of any Agent. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules. Sponsor reserves the right to modify the rules of the Promotion in any way at any time, subject to federal, state, and local law.
- **3. Promotion Period:** The Promotion begins on March 1, 2019 at 12:01 a.m. Central Time and ends on June 30, 2019 at 11:59 p.m. Central Time (the "Promotion Period").
- 4. How to Enter: During the Promotion Period, all eligible Agents will automatically receive one entry into the Promotion for each completed MoneyGram Plus Rewards transaction (excluding refunds) ("MoneyGram Plus Rewards Transaction").

Agents must obtain affirmative customer consent prior to enrolling a customer in the MoneyGram Plus Rewards loyalty program. Any Agent Sponsor reasonably suspects or finds to have enrolled customers in the MoneyGram Plus Rewards loyalty program without permission will be automatically disqualified and will be subject to disciplinary action.

5. Disclaimer: Sponsor reserves the right, in its sole discretion, to disqualify any Agent whose owners, directors, or employees are found to be tampering with the entry process or the operation of the Promotion; to be acting in violation of these Rules; to be acting with intent to annoy, abuse, threaten or harass any other Agent or person; or to be enrolling customers in the MoneyGram Plus Rewards loyalty program without their consent.

## **Grand Prizes**

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other Promotion documentation or in an Deceitful, dishonorable or disruptive manner. Any attempt to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by an Agent, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) computer error, electronic or technical malfunctions or failures of any kind, including but not limited to
