- SUMO**
- Chirongwa cheMoneyGram® chekufambiswa kwemari (“**Basa**”) chinopiwa neMoneyGram Payment Systems, Inc. (“**MoneyGram**”, “**tsu**” kana “**tsu**”) pachishandiswa vamiririri, nhome dzeepamutemo, kana mamwe masangano anotenderwa (“**Vamiririri**”). Mitemo uye Mashandiro aya, pamwe chete neGwaro (sezviri kutsanangurwa muChikamu 1.3 chiri pazasi) zvizishandiswa paBasa rinogona kusanganisira kana kubatanidzirwa Mitemo uye Mashandiro aya, ndicho chibvumirano chakazara (“**Chibvumirano**”) pakati peMoneyGram newe, iwe nyakutumirwa Basa (“**Iwe**” kana “**Nyakutumirwa**”).
- Chibvumirano chineBasa iri zvinokubumira kutambira mari yawatumirwa (“**Mari**”) pachishandiswa ISU ichibva kune (“**Munhu Atumira Mari**”). Mari yacho yatumirwa iri yenjira (currency) uye iri muwandu huri maererano nokutumira kwaiva neMunhu Atumira. MoneyGram haikuchaji mari paunotambira Mari Yawotumirwa. Unogona kutirwa basa nesu nechinangwa chaunogoziva iwe uye chinongozivikanwa neMunhu Atumira Mari chete.
- Unofanira kusaina zvakazara uye zvakarurama Chibvumirano ichi uye chero mamwe magwaro ane chokuita neMari Yari Kutumira, kusanganisira mafomu, marisiti, kana zvimwe zvinoratidza kuti wabvumirana nazvo (kureva kuti, ne “**Gwaro**” rose) kuti tikuitire Basa.
- Nokushandisa, kana kuti nokuedza kushandisa Isu chero nenziro ipi zvayo, uri kubvuma kuti (i) unobvumirana neChibvumirano chiro, (ii) kuti waverenga Gwaro rinotaura nezvekutumira Mari uye kuti mashoko ari Mugwaro racho akarurama sematsanangurirwe azvaitwa, uye kuti (iii) watabira mari yacho kubva kuHofisi Yemumiriri wedu sematsanangurirwe azvaitwa muChibvumirano uye muGwaro. Kana kuti kuti unoda kuchinja Mari yako kuti uye yeimwe nyika (currency) zvisiri muchiChibvumirano chiro, uri kubvumazve kuti kuchinja kwaMari ikoko kunenge kwatovawo rimwe Basa rakasiyana neriri kutaurwa pano uye kuti panenge pava kushanda mashoko ari Muchikamu 6 ari muChibvumirano chiro.
- Unofanira kuratidza chitupa chako chaicho kuti upiwe Mari yako. Kunyange zvazvo uchatabira referenzi namba inoenderana neMari yawatumirwa (“**Reference Number**”), Referenzi Nhaba iyoyo ingasadiwa zvayo kuti upiwe Mari yako kana pakashandiswa zvimwe zvinoratidza kuti ndive (zvakaada semibvunzo yokubata chokwadi inobunzwa neMunhu anokutumira mari) zvingashandiswa. Hatizvi nemhosha ipi zvayo kana zvikaitika kuti Mari yapiwa, kana kuri kuti zvaitika, munhu anopindura zvakarurama muvunzo wokubata chokwadi anenge aratidza zvakarurama kuti ndive kuHofisi Yemumiriri wedu achitsanangura kuti ndive munhu wacho (kunyange zvazvo anyepa kana kuti aita zvechitsotsi), kana kuti apa Referenzi Nhaba.

- Kana mune zvimwe zviitiko, ukabvuma kuti uchirega kupiwa Mari neMunhu Anenge Atumira kana neMoneyGram, chero pangava ipi zvayo paonekwa kuti wanga usina kodzero yokuwana mari yacho, zvinoitika kuti urege kupiwa Mari yacho.
- Basa redu, kana kuti kukwanisa kwako kugamuchira mari, kunganotswa, kurambidzwa kana kuti kungasakwanisa zvichienderana nezvakasarudzwa neMunhu Ari Kutumira Mari, nguva inoshanda Hofisi Inotimiriira, uwandu hweMari Yakatumirwa, mari yenjira yacho kuti iripo here, uye kuti zviri kuenderana nemitemo here, kusanganisira iya yeZitupa. Hatikutumiri Mari kana tikaziva kuti Mari yari kutumirwa iri kushandiswa kutyora mitemo, mirau, zvisungo kana kuti mitemo yeMoneyGram uye maitirwe ebasa redu, kusanganisira kudyidzana nematsotsi, kudyidzana nevaya vanoitika mabasa anotyora mitemo, kana kuti iri kukanganisa mashandisirwe emari yenjira, kana kutiswama mamwe mabasa asiri epamitemo.

- Hazividi kuti uye nemari “Yekufanobvisa” kana kuti akundi kuti ukwanise kushandisa MoneyGram kana Hofisi Yemumiriri wedu.

- INTRODUCTION**
- The MoneyGram® money transfer service (“**Service**”) is provided by MoneyGram Payment Systems, Inc. (“**MoneyGram**”, “**we**” or “**us**”) through a network of agents, authorized delegates, or other permitted entities (“**Agents**”). These Terms and Conditions, along with the Documentation (as defined in Section 1.3) used in connection with the Service to which these Terms and Conditions may be included or attached, constitute the entire agreement (“**Agreement**”) between MoneyGram and you, the individual recipient of the Service (“**you**” or “**Receiver**”).
- This Agreement and the Service allow you to receive a money transfer (a “**Transfer**”) that has been sent using our Service from an individual (“**Sender**”). The Transfer has been sent to you in a currency and amount specifically designated by the Sender. MoneyGram will not charge you any fees for receiving the Transfer. The Service is available to you only in your individual capacity known to the Sender.
- You must sign this Agreement and any other documentation related to the Transfer, including all forms, receipts, or acknowledgments (collectively, the “**Documentation**”) fully and accurately in order to use the Service.
- By using, or attempting to use, the Service in any capacity, you are acknowledging that you (i) accept the terms of this Agreement, (ii) have read the Documentation relating to the Transfer and that the information as described on the Documentation is accurate, and (iii) have received from the Agent the currency and amount described in this Agreement and/or the Documentation. To the extent you desire to exchange the Transfer into a currency other than the currency as described in this Agreement, you further acknowledge and agree that any subsequent exchange of the Transfer is a separate transaction from the Service and is subject to the provisions of Section 6 of this Agreement.
- You must provide the Agent with valid identification to receive Transfer. While you will receive a reference number that corresponds to your Transfer (“**Reference Number**”), such Reference Number is not always required to receive a Transfer where other identification means (such as test questions set by the Sender) are utilized. We will not have any liability in the event that the Transfer is disbursed, when and as applicable, to an individual who properly answers a test question, provides a valid identification to the Agent describing such person as the Receiver (even if such identification was false or forged), or provides a Reference Number.
- RESTRICTIONS ON SERVICE**
- You acknowledge that the Sender or MoneyGram, in certain circumstances, may cancel the Transfer designated for you at any time prior to your receipt and that upon such event, you will not be entitled to receive the Transfer.
- The Service, or your ability to receive the Transfer, may also be delayed, restricted or unavailable depending upon the Service selected by the Sender, Agent hours of operation, the amount of the Transfer, currency availability, and legal, and regulatory compliance, including ID requirements. We will not disburse the Transfer to you if we believe that the Transfer or the Service is being used in any way to violate applicable laws, regulations, codes or MoneyGram’s policies and procedures, including any association with fraud, anti-money laundering laws, or other illegal activity.
- If the Transfer is not disbursed to you, you may contact MoneyGram to inquire into the status of the Transfer and MoneyGram may be able to assist you, subject to all applicable laws and regulations relating to our Services and MoneyGram’s policies and procedures.
- GENERAL**
- Unless prohibited by law, we will not be liable to you for any issues arising in connection with the Transfer. In certain circumstances, the Sender may be entitled to a refund of the Transfer and/or certain fees paid in connection with the Transfer.
- The Transfer and use of the Service does not involve you having a “deposit” or an account with MoneyGram or an Agent.
- Services are directed to persons 18 years and over and may not be used for escrow purposes or gambling, and may only be used for a lawful purpose. In the event of any conflict between the English version of the Agreement and any translated version of the Agreement, the English version of the Agreement shall govern and MoneyGram will communicate with you in English.
- This Agreement does not and is not intended to confer any rights or remedies upon any person other than you and MoneyGram.
