

## Mashoko Echibvumirano

### 1. SUMO

- Chirongwa cheMoneyGram® chekufambisa kwemari ("Basa") chinopiwa neMoneyGram Payment Systems, Inc. ("MoneyGram", "isu" kana "tisu") pachishandisa vamiririn, nhume dzepamutemo, kana mamwe masangano antoterodwa ("Vamiririn"). Mitero uye Mashandiro aya, pamwe chete neGwaro (sezviri kutsanangurwa muChikamu 1.3 chirri pazasi) zvichishandisa paBaša ringona kusanganisira kana kubatanidzira Mitemo uye Mashandiro aya, ndichio chibvumirano chakazara ("Chibvumirano") pakati peMoneyGram newe, iwe nyakutumirwa Basa ("Iwe" kana "Nyakutumirwa").
- Chibvumirano chino neBaša iri zvinkubumira kutamira mari yavatumirwa ("Mari") pachishandisa ISU ichiba kune ("Munhu Atumira Mari"). Mari yacho yatumirwa iri yenika (currency) uye iri muuwandu huri maeferano nokutumira kwaitwa neMunhu Atumira. MoneyGram halukhaji mari paunotamirira Mari Yaunotumirwa. Unogona Kuitura basa nesu nechinangwa chaungozivikawa neMunhu Akutumira Mari chete.
- Unofanira kusiana zvakazara uye zvakarurama Chibvumirano ihe chere mamwe magwaro ana chokuita neMari Yauri Kutumira, kusanganisira maformu, marisiti, kana zvime zvinoratidza kuti wabvumirana nazvo (kureva kuti, ne "Gwaro" rose) kuti tikuitire Basa.
- Nokusandisa, kana kuti nokuzeda kushandisa Isu chero nerzira ipi zvayo, uru kubvuma kuti (i) onubvumirana neChibvumirano chino, (ii) kuti waverengwa Gwaro rintota nezvukumirira Mari uye kuti mashko ari Mugwaro racho akarurama sematsanangurive azvitwa, uye kuti (iii) watambira mari yacho kubva Hofsini Yemumiririra wedu sematsanangurive azvitwa muChibvumirano uye mutGwaro. Kana kuri kuti unoda kuchinja Mari yako kuti iwe yeimwe nyika (currency) zvisi muchiChibvumirano chino, uru kubvumazive kuti kuchinjha kweMari ikoko kunenge kwatvowano rimwe Basa rakasyana neriri kuturwa pano uye kuti panenge pava kushanda mashoko ari Muchikamu 6 ari muChibvumirano chino.
- Unofanira kuratida chitupa chako chaito kuti upiwe Mari yako. Kunyango zvazo uchatambira refurenzi rhumba inonderenda neMari yawatumirwa ("Reference Number"), Refurenzi Nhamba iyojo ingasidwa zvayo kuti upiwe Mari yako kana pakashandisa zvime zvinoratidza kuti ndiwe (zvakadai sembvunzo yokubata chokwadi inobvunzo neMunhu anokutumira mari) zvingashudzwa. Hatizovi nemhosva ipi zvayo kana zvakalika Mari yapiava, kana kuri kuti zvakalika, munhu anopindura zvakarurama muvbunzo wokubata chokwadi anenge aratidza zvakarurama kuti idyje kuHofsini Yemumiririra wedu achitsangura kuti ndiwe munhu wacho (kunyango zvazo anepa kana kuti ati zwechitsotsi), kana kuti apa Refurenzi Nhamba.

### 2. ZVINGATIDZISA KUTI UPIWE MARI

- Kana muu zvime zvilitiko, ukabvuma kuti uchirega kupiwa Mari neMunhu Anenge Aitumira kana neMoneyGram, chero pangua ipi zvayo paonekwa kuti wanga usina kodzero yokuverozera Mari yacho, zvinoita kuti urege kupiwa Mari yacho.
- Basa redu, kana kuti kulkwanica kwako kugamuchira mari, kungonanotwa, kurambidzwa kana kuti kungasawanisika zvichendera nezvakasardzwa neMunhu Ari Kutumira Mari, nguva inoshanda Hofsini Inotimiririra, uwandu hweMari Yaktumirirwa, mari yenika yacho kuti iripo here, ure kuti zviri kuendera nemitemo here, kusanganisira heye, zviteguta. Hatukumira kana kuti tikaziva kuti Mari yauri kutumira iri kushandisa kutura mitemo, mirau, zvisungo kana kuti mitemo yelMoneyGram uye maititwa ebasa redu, kusanganisira kudyidzana nematosi, kudyidzana nevaya vanota mbabasa anyotora mitemo, kana kuti iri kukanganisira mashandisive emari yenika, kana kuitiswa mamwe mbabasa asifit epamitemo.
- Kana usina Kutumira Mari yacho, unogona kufonera MoneyGram kuti uzive kuti Mari yacho iri muboka ripi uye MoneyGram ingakubatira, yokutsananguriva mitemo yose yatinoshandisa Mubasa redu yuemashandire anota MoneyGram.

### 3. ZVIMWEWO

- Kutoti zvichirambidzwa nemutemo, hatizovi nemhosva kana pakava nechero zvimiwe zvinoitika paMari Yawatumirwa. Mune zvimiwe zvilitiko, Munhu Anenge Atumira Mari angava nekodzero yokuverozera Mari yacho kana kuti yaakachajwa paAkakutumira Mari.
- Hazvidi kuti uve nemari "Yekufanobisa" kana kuti akaundi kuti ukwanise kushandisa MoneyGram kana Hofsini Yemumiririra wedu.
- Tinotira basa vanhu vane makore 18 nevadarika uye hatisimudziri zvianhangwa zvakalika kana zvokubbejera, uye tinotira basa iri nezinhangwa zvinotenderwa nemutemo chete. Kana zvakalika kuti mashko ari muChibvumirano cheChirungu asiyana neari muChibvumirano chakata zvokushandura, mashko ari muChibvumirano cheChirungu ndiwo achashanda uye veMoneyGram chvacatura newe nechinirwa.
- Chibvumirano chino hachina kuitura kuti chipe kodzero kana kugadzirisa zvihnu nemumwe munhu, chinongova chako neveMoneyGram chete.

## Terms and Conditions

### 1. INTRODUCTION

The MoneyGram® money transfer service ("Service") is provided by MoneyGram Payment Systems, Inc. ("MoneyGram", "we" or "us") through a network of agents, authorized delegates, or other permitted entities ("Agents"). These Terms and Conditions, along with the Documentation (as defined in Section 1.3) used in connection with the Service to which these Terms and Conditions may be included or attached, constitute the entire agreement ("Agreement") between MoneyGram and you, the individual recipient of the Service ("you" or "Receiver").

1.2 This Agreement and the Service allow you to receive a money transfer ("Transfer") that has been sent using our Service from an individual ("Sender"). The Transfer has been sent to you in a currency and amount specifically designated by the Sender. MoneyGram will not charge you any fees for receiving the Transfer. The Service is available to you only in your individual capacity known to the Sender.

1.3 You must sign this Agreement and any other documentation related to the Transfer, including all forms, receipts, or acknowledgments (collectively, the "Documentation") fully and accurately in order to use the Service.

1.4 By using, or attempting to use, the Service in any capacity, you are acknowledging that you (i) accept the terms of this Agreement, (ii) have read the Documentation relating to the Transfer and that the information as described on the Documentation is accurate, and (iii) have received from the Agent the currency and amount described in this Agreement and/or the Documentation. To the extent you desire to exchange the Transfer into a currency other than the currency as described in this Agreement, you further acknowledge and agree that any subsequent exchange of the transfer is a separate transaction from the Service and is subject to the provisions of Section 6 of this Agreement.

1.5 You must provide the Agent with valid identification to receive Transfer. While you will receive a reference number that corresponds to your Transfer ("Reference Number"), such Reference Number is not always required to receive a Transfer where other identification means (such as test questions set by the Sender) are utilized. We will not have any liability in the event that the Transfer is disbursed, when and as applicable, to an individual who properly answers a test question, provides a valid identification to the Agent describing such person as the Receiver (even if such identification was false or forged), or provides a Reference Number.

### 2. RESTRICTIONS ON SERVICE

2.1 You acknowledge that the Sender or MoneyGram, in certain circumstances, may cancel the Transfer designated for you at any time prior to your receipt and that upon such event, you will not be entitled to receive the Transfer.

2.1 The Service, or your ability to receive the Transfer, may also be delayed, restricted or unavailable depending upon the Service selected by the Sender, Agent hours of operation, the amount of the Transfer, currency availability, and legal, and regulatory compliance, including ID requirements. We will not disburse the Transfer to you if we believe that the Transfer or the Service is being used in any way to violate applicable laws, regulations, codes or MoneyGram's policies and procedures, including any association with fraud, anti-money laundering laws, or other illegal activity.

2.2 If the Transfer is not disbursed to you, you may contact MoneyGram to inquire into the status of the Transfer and MoneyGram may be able to assist you, subject to all applicable laws and regulations relating to our Services and MoneyGram's policies and procedures.

### 3. GENERAL

3.1 Unless prohibited by law, we will not be liable to you for any issues arising in connection with the Transfer. In certain circumstances, the Sender may be entitled to a refund of the Transfer and/or certain fees paid in connection with the Transfer.

3.2 The Transfer and use of the Service does not involve you having a "deposit" or an account with MoneyGram or an Agent.

3.3 Services are directed to persons 18 years and over and may not be used for escrow purposes or gambling, and may only be used for a lawful purpose. In the event of any conflict between the English version of the Agreement and any translated version of the Agreement, the English version of the Agreement shall govern and MoneyGram will communicate with you in English.

3.4 This Agreement does not and is not intended to confer any rights or remedies upon any person other than you and MoneyGram.
