SCHEDULE C

ON-SITE SUPPLIER

These on-site supplier terms and conditions ("*Terms*") constitute an agreement between MoneyGram Payment Systems, Inc. ("*Customer*") and you ("*you*" or "*Supplier*") related to your provision of Goods and/or Services to Customer. Terms capitalized herein but undefined shall have the definitions assigned them in the master services agreement executed by and between Customer and the Supplier.

1. Health and Safety.

- 1.1. While on property owned or controlled by the Customer, or property owned or controlled by a third party but at the invitation of the Customer (collectively, a "*Property*"), Supplier and its Representatives shall comply with all applicable rules, laws and regulations relating to health and safety, whether promulgated by the Customer, a third party, or a local, state, or federal governmental body.
- 1.2. Supplier and its Representatives shall comply with all posted safety requirements at a Property, including but not limited to rules concerning: hearing protection, eye protection, confined space entry, access barriers, parking and driving requirements.
- 1.3. Supplier shall furnish proper safety equipment at Supplier's cost and enforce the use of such equipment by its Representatives. Supplier's failure to correct an unsafe condition after notice thereof shall be grounds for an order to suspend the affected operations until the unsafe condition is corrected all at Supplier's expense and, if the violation continues, to terminate a SOW or MSA for Supplier's default for such failure.
- 1.4. Prior to entry on Property, Supplier and its Representatives shall coordinate with Customer to gain access to a Property. Supplier and its Representatives shall provide information reasonably required by the Customer to ensure proper identification of Supplier personnel including, but not limited to, verification of citizenship, lawful permanent resident status, protected individual status, or other status.
- 1.5. Badges and proximity cards issued to Supplier remain a Property of the Customer and must be returned to Customer upon request. Failure by Supplier to return badges in the possession of its employees will result in a charge of \$500 per badge. The charge will be deducted from payments otherwise due Supplier, or will be billed to Supplier directly.

2. Conduct by Supplier and its Representatives.

- 2.1. Supplier and its Representatives are to stay within assigned work areas, and to not otherwise wander or enter areas not specified by Customer as required for the provision of Goods and/or Services under the applicable SOW or MSA.
- 2.2. Supplier shall keep said premises and the vicinity thereof clean of debris and rubbish caused by its work and, upon completion of its work, shall leave the premises clean and ready for use.
- 2.3. Supplier and its Representatives shall conduct themselves in a professional manner. Use of offensive language and display of offensive materials is not permitted, including but not

- limited to racist, sexist, homophobic, transphobic, abusive or discriminatory language or materials reflecting such language.
- 2.4. Horseplay, theft, fighting, harassment, and gambling are strictly prohibited.
- 2.5. Animals are not to be brought onto a Property, except for pre-approved service animals.
- 2.6. Firearms or other weapons, and ammunition are strictly prohibited and may not be brought onto a Property, including in a personal vehicle. Other weapons include any instrument or device that is both dangerous and not required for Supplier's provision of Goods and/or Services such as knives, swords, bows, arrows and similar objects, along with their mock or non-functional equivalents.
- 2.7. Supplier and its Representatives shall not manufacture, sell, distribute, possess, use, or be under the influence of controlled substances or alcoholic beverages while on a Property.
- 2.8. Tobacco use of any kind is prohibited on a Property, except for in designated locations. This prohibition includes the use of any product that gives the appearance of using tobacco (ex. e-cigarettes, vaporizers, herbal chew, etc.)
- 2.9. Supplier and its Representatives shall not conduct any non-Customer related business activities (such as interviews, hirings, dismissals, or personal solicitations) on Property.
- 2.10. Supplier and its Representatives shall not send or receive non-Customer related mail through Customer's mail systems.
- 2.11. Supplier and its Representatives shall not sell, advertise, or market any products or memberships, or distribute printed, written, or graphic materials, on a Property without Customer's written permission or as specifically permitted by law.
- 2.12. Supplier and its Representatives shall not use phone or electronic device on a Property while walking or operating vehicles or equipment, unless hands-free.
- 2.13. Supplier and its Representatives shall not take pictures or video or use cameras (whether standalone or integrated into another electronic device) while on a Property unless such pictures or videos are pre-approved in writing by Customer.
- 2.14. Use of Customer assets such as equipment, machinery, tools, utilities, etc., are prohibited without prior written consent by Customer. The use of Customer assets by Supplier or its Representatives is generally forbidden unless there is a specific business need such as unique tooling required for a project or additional risk incurred in operating portable equipment such as cranes. Supplier and its Representatives shall not remove Customer assets from Property without Customer's prior written authorization.
- 2.15. Supplier shall promptly notify Customer in writing of any Incidents and shall provide a report of any such Incidents. An "*Incident*" is any unplanned event that results in or has the "potential to result" (i.e., near miss) in (i) occupational injury/illness or environmental impact, or (ii) loss of or misuse or damage to Customer's intellectual or physical assets.
- 3. Miscellaneous.

- 3.1. All persons, property, and vehicles entering or leaving a Property are subject to search.
- 3.2. Upon request of Customer and at no cost or expense to Customer, Supplier shall promptly remove from a Property any person under the control of Supplier who violates any of aforesaid safety, health, or plant laws, regulations, ordinances or rules or who may cause or threaten to cause a breach of the peace, or any other disturbance of the work.
