SWEEPSTAKES DESCRIPTION: MONEYGRAM – DREAMS COME TRUE SWEEPSTAKES (the “**Sweepstakes**”) begins on July 1, 2018 at 12:00:00AM Eastern Time (“**ET**”) and ends on July 31, 2018 11:59:59PM ET (the “**Sweepstakes Period**”). The Sweepstakes Period consists of two (2) monthly drawings (each, a “**Monthly Drawing**”) to award prizes in a random drawing conducted from among all eligible entries received during the corresponding calendar month. Participation in the Sweepstakes does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of MoneyGram Payment Systems, Inc., 1550 Utica Avenue South, St. Louis Park, MN 55416 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents who are of the majority age in their place of residence and who are MoneyGram Plus Rewards Premier members as stated in the [MoneyGram Plus Rewards Terms and Conditions](#) at the time of entry are eligible to participate.

Officers, directors, employees, temporary employees, independent contractors, interns and agents and other representatives of MoneyGram Payment Systems, Inc. and its parent, subsidiaries, and affiliates (“**MoneyGram**”) and their retail agents, advertising agencies and any other company or individual involved with the design, production, execution or distribution of this Sweepstakes (collectively, “**Sweepstakes Entities**”), including but not limited to each of their immediate family members (spouse, parents, children and siblings, and their respective spouses) and individuals living in the same households of each of these individuals, whether related or not, are ineligible to enter or win prizes.

WINNER SELECTION AND NOTIFICATION: At the conclusion of each month, the fifty-one (51) potential prize winners will be randomly selected from all eligible entries received during the corresponding calendar month. Monthly Drawings will take place on or about the 15th of each subsequent month. The potential prize winners will be notified by telephone and/or mail and/or e-mail, using contact information associated with such potential winner’s MoneyGram Plus Rewards membership or provided at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.
